Invest in CCD Renovation

At the December 19, 2017 Country Club of Decatur Board meeting, 14 Board members were present and unanimously approved a one-time assessment for the fiscal year 2017-2018 applicable to all Club members to fund the renovation of the lower level dining room/bar area and to construct a wooden deck along the northwest side of the clubhouse. The additional outdoor seating will extend along the north end of the Clubhouse to provide outdoor enjoyment and provide views of the lake and the #9 hole of the golf course. The details of the assessment and investment opportunities are attached.
